Terms and Conditions

By signing this electronic funds transfer (EFT) authorization form, you have authorized Greater Portland Bible Church (GPBC) to arrange for funds to be debited from your account on a monthly or semi-monthly basis. We will only arrange for funds to be debited from your account as authorized by you in this agreement. If you wish to increase, reduce or discontinue your monthly contributions, you must notify us in writing or by email and allow a reasonable amount of time to change your EFT status. If the transfer day falls on a day that is not a business day, we may direct your financial institution to debit your account on the previous or following business day. If you have questions or would like a statement of your EFT contributions, you can contact the GPBC finance office at 503-452-9375 or eft@pdxchurch.org. GPBC will not charge you any fees to sign up and use EFT as your contribution method. It is your responsibility to ensure that there are sufficient funds available in your account to allow a debit contribution to be made in accordance with your EFT request. If there are insufficient funds to meet a debit payment you may be charged fees by your financial institution. You should check your account statement to verify that the amounts debited from your account are correct. If you believe that there has been an error in debiting your account, you should notify GPBC directly at (503) 452-9375 or at eft@pdxchurch.org. If upon investigation an error is found to have been made, we will correct it as soon as possible. If we cannot resolve the matter, you can still refer it to your financial institution which will obtain details from you of the disputed transaction and may lodge a claim on your behalf. We will keep any information (including your account details) in your EFT request confidential. We will make reasonable efforts to keep any such information that we have about you secure and to ensure that any of our employees or agents who have access to information about you do not make any unauthorized use, modification, reproduction or disclosure of that information.

A Simple Way to Give

- -Electronic Funds Transfer provides a convenient way for you to make your contributions the same time each month, even if you can't make a Sunday.
- -Gifts are automatically deducted from your checking or savings account each month.
- -Signing up for Electronic Funds Transfer reduces the church's overhead costs, making your gift stretch farther.



How to Sign Up

It takes three simple steps...

- 1. Fill out the EFT Authorization Form to the right. Make sure to sign your name and include the monthly gift amount and today's date.
- Attach a voided check (if you choose to have deductions come from your checking account) or a deposit slip (if you choose to have deductions come from your savings account).
- 3. Submit the form and the attached check/slip to the finance office either by placing this in the offering basket on Sunday or mailing it to the church office.

That's it! It's that easy!

You will receive a letter or email confirming your EFT enrollment. Each month the transfer occurs automatically and the record of giving appears on your bank account statement. You will also continue to receive giving summaries from the church for your tax records. If at any time you wish to discontinue using EFT, simply drop us a note or email us at:
